














Location

Tax Benefits

THE BEST TURNKEY OPPORTUNITY ZONE INVESTMENT IN THE COUNTRY

- Opportunity Zones are designated areas for economic improvement across the US. They come with huge tax benefits. A 1-mile stretch of Marathon is the **ONLY** Opportunity Zone in the Florida Keys. **This property is in it.**
- How would this work for me on this deal?
 - 1. Utilize 100% of recent financial gains by deferring Capital Gains tax and putting cash toward the purchase of a new house in the Keys
 - 2. Use and/or rent home. Take depreciation. Leverage through debt if desired. Enjoy an awesome home in the Keys!
 - 3. Settle original Cap Gains tax in Dec 2026 (or 2028 if new law gets passed) and get a 10% discount on what is owed
 - 4. Sell after 10 year hold tax-free (one-time step up in basis) and no recovery of depreciation taken!
- Opportunity Zone Background, Rules and Benefits:
 - Far better and more flexible than a 1031 exchange
 - Original capital gains don't need to be settled till Dec. 2026, and only 85% of the original gain is owed (reduced original base by 15%). Legislation in process to extend this to December 2028.
 - "Significant improvement" must be accomplished within 30 months. This is defined as doubling the value of the investment. *Land value is excluded! This is key! New construction is ideal.*
 - Assets held in the Opportunity Fund receive tax-free appreciation if held for 10 years (IRS provides a step-up in Basis equal to the market
 rate at the 10-year mark when assets are divested). After the 10-year hold, all assets can be sold tax-free, no depreciation recapture.
 - Each house sold prior to Cert. of Occupancy gets Opp Zone treatment for the buyer!
 - This property is a very unique Opportunity Zone asset! One of the best in the US.
